Introduction section should contain background of the problem, related theories, previous research (if any), hypothesis (if any), and objective of the research. Introduction refers to references, which become the underlying theories in conducting the research. (Times New Roman, 12pt, 1.5 space).

The manuscript derived from the result of the research and written in English will be prioritized. The manuscript(s), which discusses the possible development of theories or suggested ideas in English language, is considered to be accepted in this journal.

If there is sub-sub section, the title should be written in italic and capitalized for each word

#### C. FINDINGS AND DISCUSSION (Times New Roman 12pt, Bold)

The title of this section should be written in capital letter, 12pt, and bold. This section is organized systematically, and only the related results or information of the research should be discussed here.

#### *Findings* (Times New Roman, 12pt, Bold and Italic)

This sub section should be written in capital letter in the first letter, 12pt, bold and italic. This sub section displays the data or information obtained through the correct procedure of the aforementioned research method. The findings also should answer the research question(s) stated.

The table (if any) is displayed using open table and the title of the table should be written in Times New Roman, 12pt, sentence case. There should not be vertical lines and horizontal lines are allowed if needed. Paragraph spacing of the table should be in one space.




Figure 1. the Different Mean of GTM, ALM, TPR for Each Meeting

Conclusion (Times New Roman, 12pt, Bold and Italic)

This subsection describes the answer of the hypothesis and/or the purpose of the research or the findings obtained. The conclusion does not discuss the repetition of the finding(s) and discussion sections.

## Suggestion (Times New Roman, 12pt, Bold and Italic)

This sub section provides suggestion(s) related to the upcoming idea(s) coming from the result(s) of the current research.

## **E. REFERENCES**

All citations in the article should be listed in References. References should refer to the primary sources like book(s), or article(s), which were published at last 10 year. They should be written based on APA 6<sup>th</sup> Edition in 1 space and 1 space between references.
